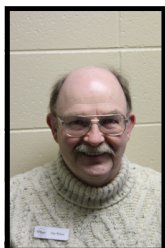

Alan Lacer has been involved in the turning field for over 35 years as a turner, teacher, writer, exhibition coordinator, expert witness, demonstrator, and past president of the AAW. His work has appeared in a number of regional and national exhibitions. Alan has been a regular instructor and demonstrator of the craft—having worked in all 50 states, as well as 5 foreign countries. He has published over 150 articles, columns, and tips, covering technical aspects of woodturning, and many specific projects, stories related to both contemporary and historical woodturning, and the turning traditions of Japan and Germany. He has also produced five videos on his own, with three of them winning a total of five national awards. In 1999, the AAW awarded him their Lifetime Honorary Member Award for his contributions to the field of woodturning. He has also appeared on national TV woodturning programs on PBS and DIY.

I hope that you attend this great demonstration. I look forward to seeing you there.

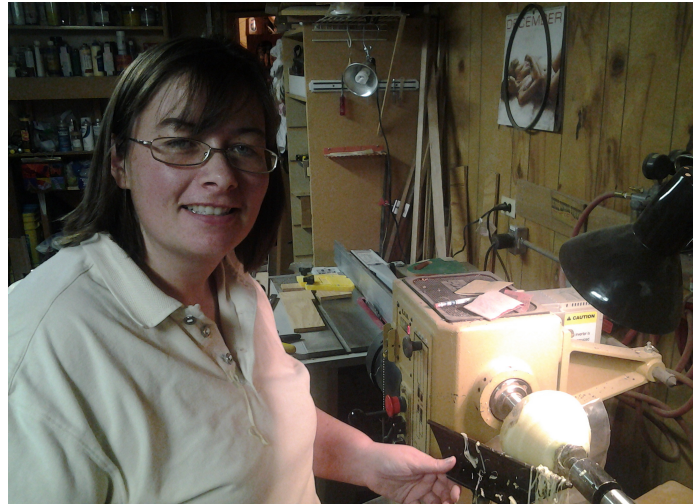


January Mentoring Session

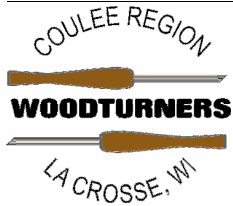
