

A charter member, a very skilled turner who has forgotten more than I will probably ever know. He wears many hats in the club and helps keep the business of recording or demos going. Along with Bob Raasch, Adrian Novak and a few others. I will also mention the contributions of Ginie Wintersteen and Gary Friemann in their roles of Secretary and Treasurer. They keep the nuts and bolts of the club sorted and counted. They are invaluable. Be sure to take a moment to thank them in person.

So, how about the demo we had in March? Always important to talk about the unpleasant stuff like turning safety. Mark Palma, our demonstrator did a masterful job of approaching the topic. Our thanks to Adrian for getting him on the schedule and to him for his demo. As a fisherman, I'm here to tell you those lures he makes would have an extremely subtle action. Just the ticket for very gun-shy bass. (There I go talking about fishing again.)

Our April meeting will feature our own Larry Gehl talking about segmented work. Who knows, that may be what it takes to get me to do segmented work. It was our demo on pen making a few years ago that got me turning Sierra pens. I bought a bunch of kits, a mandrel and bushings, and the rest is history. Now I create some cool stuff for writing too. So make sure you show up for the meeting, bring something for the instant gallery and enjoy the morning.

We have mentioned a time or three over the past few months that the library case is getting a little crowded. TMI as some say, too much information being crammed in too few shelves. Jack Fitzpatrick built a fantastic case a few years ago that was more than adequate but we have outgrown it. It just cannot be expanded. The board decided to build a new case that will increase the feet of shelf space by 50%. Phil Miller and Adrian Novak will build it, it will be two sided and not increase the overall footprint of the case. That is important since we have a lot of stuff we have to keep in the cage. The old case will be auctioned off when the new one is complete and our very capable auctioneer/program director will do the auctioning at an upcoming meeting. So sooner or later the case will be complete, the switch will take place and some lucky member gets to take a pretty cool case home with them.

Bob Patros has been kind enough to set up a display of turned pieces in the display case on the third floor of Gundersen Clinic near the walkway over the street between the East and Founders buildings and the main clinic. He will be taking items at the next couple of meetings and Jim Frank will be creating the name cards for each one. My contribution will be a couple of mid sized walnut bowls and I will bring them to the April meeting.

Those who attended the last meeting noticed some improvement in the video quality. Rich Egan, Adrian and Bob made some changes in cables and camera placement that helped but the sad truth is, one camera is failing. Cheap video cameras are available but do not produce a clear picture. Quality used cameras are available on internet auction sites for a small amount but if they work or how long they will work is problematic. The board is not inclined to gamble with members money by buying a pig in a poke. So we are going to do some improvements over time with the long term goal to be using high definition cameras and big screen TV sets but that takes moola so the improvements will be piecemeal. We decided to set aside the income from the meeting auctions to pay for the equipment.

Upcoming meetings promise to be interesting. In May we meet at A Line and Phil will demo. He is just not certain yet what he will present. June we go to Stevenson's for a trip through their museum and will be treated to a pot Luck and John Frawley's demo.
